- At the sanctioned show the following divisions must be offered:
  - Market Lamb Division (Top 5 Overall)
  - Market Lamb Breed Divisions (**NEW FOR 2017!**)
    - Hampshire
    - Suffolk
    - White Face
    - Speckle Face
    - Natural
    - Crossbred
  - Commercial Ewe Division (Top 3 Overall)
  - White-Face Cross (WBI) Division (Top 3 Overall)
  - Showmanship – Sr 16-21, Intermediate 11-15, Junior 10 & under
- If any requirements of the HYSLC are not met by the show, the HYSLC committee has the option to not sanction that show in future years.
